Safeguarding Children Policy

- Manuden Junior Football Club acknowledges its responsibility to safeguard the
 welfare of every child and young person who has been entrusted to its care and is
 committed to working to provide a safe environment for all members.
 A child or young person is anyone, under the age of 18, engaged in any club football
 activity. We fully subscribe to The Football Association's Safeguarding Children Policy
 and Procedures and endorse and adopt the Policy Statement contained in that
 document.
- 2. The key principles of The Safeguarding Children Policy are that;
 - · The child's welfare is, and must always be, the paramount consideration.
 - · All children and young people have a right to be protected from abuse regardless of their age, gender, disability, culture, language, racial origin, religious beliefs or sexual orientation.
 - · All suspicions and allegations of abuse will be taken seriously and responded to swiftly and appropriately.
 - \cdot Working in partnership with other organisations, children and young people and their parents or carers is essential.

- · We acknowledge that every child or young person who plays or participates in football should be able to take part in an enjoyable and safe environment and must be protected from poor practice and/or abuse.
- 3. Manuden Junior Football Club recognises that this is the responsibility of every adult involved in our club to safeguard the welfare of all participants.

Manuden Junior Football Club has a role to play in safeguarding the welfare of all children and young people by protecting them from physical, sexual, or emotional harm and from neglect or bullying. It is noted and accepted that The Football Association's Safeguarding Children Regulation (See the FA Handbook) applies to everyone in football whether in a paid or voluntary capacity. This includes those who are volunteers, match officials, helpers on club tours, football coaches, club officials or medical staff. Each associated member of the Manuden Junior Football team is asked to follow the relevant online Safeguarding

- 4. Manuden Junior Football Club endorses and adopts The FA's Safeguarding Children Guidelines for Recruiting Volunteers and will:
 - · Provide a role profile for any positions held within the Club
 - · Request identification documents
 - · Meet and chat with the applicant(s) and conduct interviews before appointing
 - · Require a DBS Enhanced Criminal Record with Children's Barred List Check to be successfully undertaken before commencing work with any group of children within the Club.
 - · Review code of conduct documentation

Manuden Junior Football Club aims to prevent people with a history of relevant and significant offending from having contact with children or young people and the opportunity to influence policies or practice with children or young people. This is to prevent direct sexual or physical harm to children and to minimise the risk of 'grooming' within football.

- 5. Safeguarding children is everyone's responsibility. If any member has a concern about a child it is important that these concerns are reported.
 - · If you are worried about a child then you need to report your concerns to the Club Welfare Officer.
 - · If the issue is one of poor practice they will either deal with the matter themselves or will seek further advice from the Essex FA Child Welfare Officer.

- · If the concern is more serious possible child abuse where possible contact the Essex FA Child Welfare Officer first, then immediately contact the Police or Children's Services.
- · If the child needs immediate medical treatment take them to a hospital or call an ambulance and tell them this is a child protection concern. Let the Club Welfare Officer know what action you have taken.
- · If at any time you are not able to contact the Club Welfare Officer or the matter is serious then you can either:
 - 1. Contact the County FA Welfare Officer on 0191 2701166 or via email at helen.hever@essexfa.com,
 - 2. Call The FA/NSPCC 24 hour Helpline for advice on 0808 800 5000
 - 3. Contact the Police or Children's Services
- 6. Manuden Junior Football Club acknowledges and endorses The FA's identification of bullying as a category of abuse. Bullying of any kind is not acceptable at our Club. If bullying does occur, all players, parents or guardians should feel free to speak out and know that incidents will be dealt with promptly.
 - Incidents need to be reported to the Club Welfare Officer, a member of the Club Committee, or in cases of serious bulling contact the Essex FA Child Welfare Officer.
- 7. Manuden Junior Football Club has implemented Codes of Conduct for all club members (ie Players, Parents or Spectators, Officers, Managers and Coaches). All members are required to sign a copy of the Clubs Codes of Conduct each season. The club has clear procedures to deal with any misconduct at club level and acknowledges the possibility of potential further sanctions, which may be implemented by Leagues or the Essex FA in more serious circumstances.
